On 13 June, 2011 over 850 TIST Farmers and friends of the TIST Program met at the Gitoro Conference Center in Meru, Kenya.

We celebrated TIST Farmers' "First in the World" Carbon Verification from the Verified Carbon Standard (VCS) and the Climate, Community, and Biodiversity Alliance (CCBA), the signing of the KFS Memorandum Of Understanding that will allow TIST farmers who are in a CFA to plant in riparian and catchment areas in the forest, and the approval of funding by USAID for improving the TIST Program.

The celebrations started with a road procession from Kinoru stadium to Gitoro CCM primary school where we joined pupils and teachers to plant over 400 trees around the school and on riverbank beside it. Thereafter, we gathered at Gitoro Conference Center where trainings were conducted and speeches delivered.

USAID's Enock Kanyanya, Damaris from NEMA, Mr. Odongo Imenti North D.O. and KFS Zonal manager graced the occasion.

Also in attendance was Joshua Irungu, former TIST Administrative Director, representatives from all TIST clusters in Kenya, and TIST representatives from Tanzania and Uganda.

Ben read a congratulatory message from Joseph Rexon of TIST India.

Enock praised TIST efforts in planting trees and monitoring their growth accurately. He said that USAID is ready to continue supporting TIST.

Damaris recognized the important role TIST is playing by engaging farmers in planting of trees. She challenged the program to reach out to young people as well. She added that TIST is helping achieve Millennium Development goals through poverty eradication and



environmental improvement.

Imenti North DO I, Mr Odongo lauded TIST efforts in larger Meru county and in other areas as well in economic development and in improving the environment.

Evans, KFS Zonal Manager, appreciated the newly signed Memorandum of Understanding (MOU) between Clean Air Action Corporation (CAAC) and Kenya Forest Service (KFS). "This new partnership will enable us to work closely with farmers in conserving and protecting our forest particularly in Mt. Kenya", he added.

Farmers were entertained by local cultural dance groups. Kibarnyaiki Cultural Dancers performed the TIST dance they had prepared. Kirinyaga TIST Clusters also performed a TIST song.

Trainings.

Notably, farmers and leaders organized themselves to receive trainings. There were 16 training stands. These stands were organized in regions where neighboring clusters were gathered to receive important trainings

and information materials. There was also an energy efficient jikos display and training stand, riparian and indigenous trees stand, and videos stand.

The participants were requested to share the information they learned with other Small Groups in their Clusters, and highlights are included in this issue

Vannesa led selected leaders and Uganda and Tanzania TIST representatives amidst jubilations in cutting of the cake.

Later, we were treated to a delicious meal and thereafter, people left back to their homes.

This celebration is for all of us in TIST Kenya, and for our TIST family around the world. Let us take home the joy and pride of our achievements, and work together to achieve even bigger results in the days to come. Recruit new Small Groups to your cluster. Plant more trees to make your farms and rivers green and earn more carbon income. Use the training received to report your cluster's successes and share best practices. If we all work together, we can achieve great things.



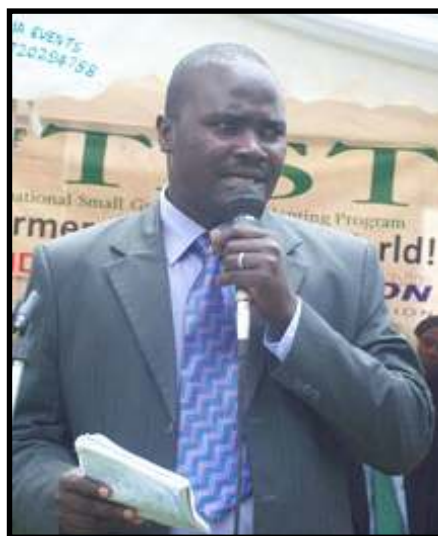

On 6th June 2011, TIST farmers witnessed the signing of a Memorandum of Understanding between Clean Air Action Corporation (CAAC) and Kenya Forest Service (KFS). This MoU will create a long-term partnership between KFS and TIST farmers in planting of indigenous trees in riparian and catchment areas within forest areas.

The signing ceremony was held at KFS headquarters, Karura Forest, Nairobi. Approximately 40 TIST participants from Meru, Nanyuki, Kirinyaga, Mbeere and Mara attended the occasion. Ben and Vanessa Henneke lead the TIST Team while KFS Director, David Mbugua led the KFS Team. USAID, a major partner in TIST was well represented by USAID's Kenya Mission Director, Erna Kerst, and other USAID officials.

In his address, David recognized the need to have community partnerships and partnership in restoring country's tree cover. He noted that currently, the country has a tree cover of less than 2% against the international recommended 10%. This, he said, is an enormous challenge that no single agency can achieve alone. He therefore pointed out that partnership like the one being witnessed on this day is the way to go. In his concluding remarks, he said, "with TIST, we are partners."

Erna appreciated continued TIST enthusiasm and effort in serving more farmers and making them aware of the importance of environmental conservation. She praised TIST success in attaining the Verified Carbon Standard (VCS) and Climate Community Biodiversity Alliance (CCBA) standards. TIST is first in the world to

receive approval under those two standards at the same time.

Ben thanked KFS for getting this MOU signed. He explained that the MOU heralds a new and added focus where TIST farmers will directly participate in improving forest areas near their farms. "Many of our farmers in nearby forest areas have little land. They have been unable to plant significant number of trees that would enable them actively participate in carbon markets. This MOU opens an access for them to fully participate and have access to the carbon business. Further, young people and some women, who have largely been discriminated by land tenure issues, will have a chance to now plant trees and earn carbon income", he added.

Dorothy Naitore, a TIST trainer and Leadership Council member, gave her address on behalf of TIST Farmers. She said that Farmers have been waiting for this partnership for long. They are excited to see this partnership move to implementation stage.

The signing was met with jubilation and ululations from TIST participants and other guests.

Next Steps.

TIST will be working with consultants and TIST servants including Small Group members to develop Forest Management plans which will operationalize the signed MOU.

TIST Farmers and leaders organized themselves to receive trainings during the celebrations. These Trainings included:

How to qualify for future Carbon Market Sales (Information Quality)

TIST Trainers explained to celebration participants that not all TIST groves are currently eligible for the sale of Carbon Credits. They explained that this is different than being eligible for the TIST tree payment. Good quality, complete data from quantification is needed for carbon sales that keep TIST running and pay for tree payments and TIST growth. Trainers explained that groves may need to have a second GPS track taken, may be missing a GHG contract, or may be missing baseline information. Cluster Representatives and Area Coordinators (see article below) will be working to improve this situation

so that all groves can qualify for future Carbon Sales by December 31, 2011.

How to report Cluster Budget and Cluster Meetings using SMS

Transparency and mutual accountability is key values of TIST, and each TIST cluster must report how it spends its 900/= cluster budget to achieve big results. TIST has developed a new and easier way for Clusters to report their monthly budget use their Cluster Meeting Records using SMS. This new approach allows a TIST member to send an SMS from their phone to a central phone number. SMS messages will be collected and analyzed by TIST staff. If a cluster has access to a working Palm, they should use the Cluster Meeting and Accounting Forms on the Palms. However, with this new method,



every cluster should report every month. This approach will simplify reporting for Cluster Representatives and help TIST staff support Cluster activities. For more information on SMS reporting, contact your Cluster Representatives or your Area Coordinator (see article below).

Conservation Farming

Participants viewed examples of conservation farming techniques and asked questions of TIST Master Trainers. Conservation farming can improve crop yield even in drought, reduce erosion, reduce cost through use of organic manure, improve soil quality, and lead to less labor. For more information on CF, contact your Cluster Representatives or local Trainer.

Fuel-Efficient Stove Jikos

Participants viewed varied TIST jikos, including self-built models and manufactured stoves. Fuel-efficient stoves reduce smoke in the home to protect your family, reduce your expenses on fuel wood, and reduce the amount of time spent gathering wood. TIST members can buy a jiko directly through TIST or take part in the Helped to Help Program. There are different stove models available so you can choose the one that works best

for your family. See photos and prices below. In Helped to Help, participants who agree to monitor their fuel usage, and to buy stoves for cluster members from savings from fuel wood, may receive a jiko at no cost. For more information, or to buy a TIST jiko, ask your cluster representatives to contact Dorothy Naitore at 0726788662.

Riparian Payment for Environmental Services (PES) Pilot Program

Celebration participants learned about TIST's pilot riparian program, that provides an extra incentive of 1 ksh per indigenous tree per year in a qualifying riparian grove and 0.3 ksh per indigenous seedling per year in a nursery if the group has a qualifying riparian grove. The pilot project presently includes Sirimon, Burguret, Tigithi, Kinyaritha, Mariara, Mara, Thanatu, Muruku, Kirugwa, Nyamidi, and Gakuru Rivers. Groves must be within 100 meters of a river, have at least 30% indigenous trees, no more than 5% eucalyptus, no eucalyptus within 100 meters of the river, and no cultivation within 30 meters of the river. New Service structure: Another new level towards prosperity.

Beginning in July, 2011, TIST will introduce a new, temporary service structure. This is meant to help Clusters move towards self-governance and low-cost, high-quality service. The sooner we have good data so we can have more cash sales, and the lower we can make costs, the sooner we will be profitable so that 70% of carbon profits can come to TIST farmers.

The new structure involves 19 "Area Coordinators and Co Coordinators" who will help Clusters to:

- Improve grove data quality so more groves are eligible for carbon market sales.
- Help Clusters to learn the new SMS accounting and Cluster meeting reporting systems.
- Assist Clusters to hold democratic elections, if they are not already doing this, to choose Leader, Co-Leader, and Accountability Person.
- Help Clusters to learn how to organize their own quantification and training.
- Make sure that Cluster Meetings are happening every month, and TIST members are attending Teach Clusters to manage their 900 ksh/month budgets.
- Ensure that Clusters are able to distribute payments to Small Group members themselves.

Area Coordinators will work with Quantifiers and Trainers for their area to coordinate quantification and trainings needs. As part of this new system, Quantifiers

will no longer work in pairs; instead, one quantifier will be assisted by the Cluster Accountability Person or another person chosen by the cluster to complete quantification work. This will allow Clusters to have a hand in their own success and money earning opportunities. Area Coordinators will work until December 2011 to move Clusters towards self-sufficiency and improved data quality for the Carbon Market.

We all need to work together to achieve this goal. Come to cluster meetings, and encourage Small Groups in your cluster to attend. Organize with your cluster representatives and quantifiers to make sure your quantifications are complete and accurate. Know how many trees you have planted, and make sure that the counts for your group are accurate. Plant more trees to help your cluster achieve its goal and to help TIST grow.

How is your cluster doing?

The list below shows how many trees have been quantified in each cluster and how many of these trees have good, complete data required for carbon sales. Remember, our goal is for each cluster to have at least 250,000 quantified trees, and 100% of trees qualifying for carbon sales.

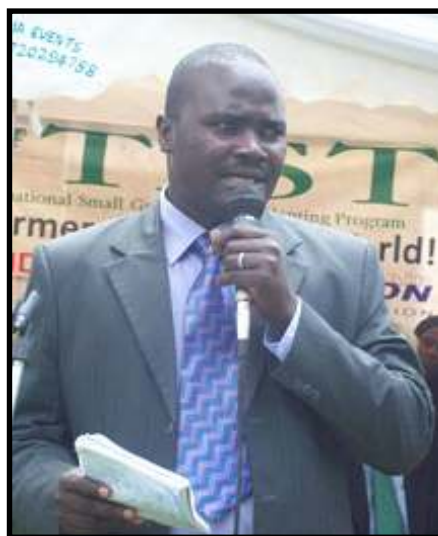

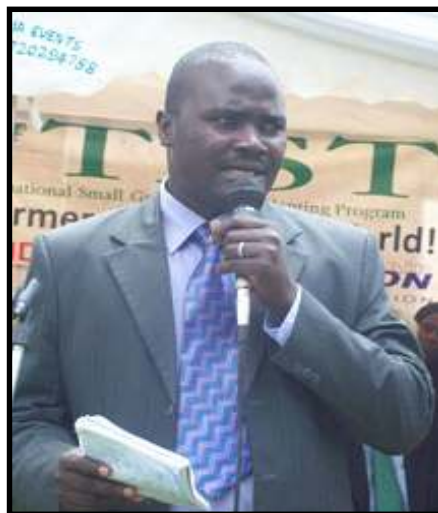

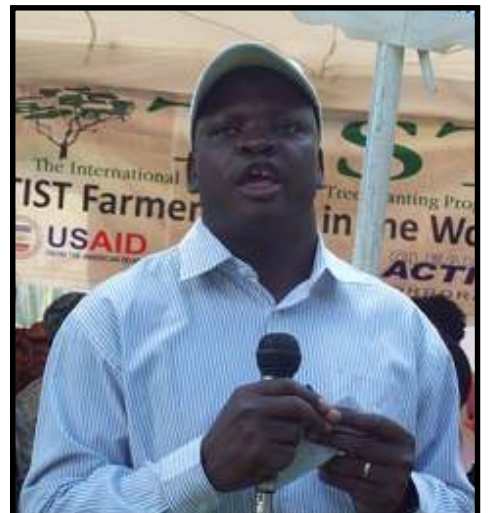

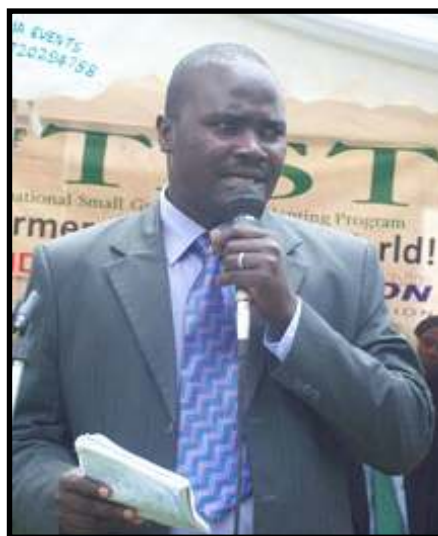
